GENERAL INSTRUCTIONS FOR APPLICANTS

- 1. Application form along with other details and qualifications (As amended up to date) are available on University Website www.vbspu.ac.in as per the UP State Government orders/U.G.C./AICTE norms (as applicable). Application form and other details can be downloaded from the University website.
- Application must be accompanied with a non-refundable demand draft of Rs. 1000/- for General/OBC and Rs. 500/- for SC/ST/DA drawn in favour of "Finance Officer, V.B.S. Purvanchal University, Jaunpur" payable at Jaunpur with the application form. Application fee once paid will not be refunded under any circumstances.
- 3. Those candidates who had applied earlier they need not to apply again, however, they may send their updated application. They need not to pay application fee again.
- 4. The name of the Post must be mentioned on top of the envelop.
- 5. The application form duly filled in the prescribed format along with required documents must reach to the **Registrar**, **V.B.S. Purvanchal University**, **Jaunpur -222003**, **U.P.** through Registered/Speed Post on or before **06 November 2019** (**Wednesday**) at **5.00 PM**.
- 6. Incomplete applications and applications received after last date will not be considered and will be summarily rejected.
- 7. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

- 8. Relevant grade which is regarded as equivalent to 55% where the grading system is followed by recognized University shall also be considered eligible. Conversion of grade to percentage certificate must be provided by the applicants.
- 9. The eligibility of the applicants will be determined on the basis of the last date of submission of the application form.
- 10. Mere eligibility will not entitle any applicants to be called for interview.
- 11. Applications not accompanied with necessary supporting documents, self-attested copies of degree certificates/ marks sheets/experience certificate/category certificate/publication/reprints (if applicable) issued by the competent authority and the incomplete applications shall be rejected summarily.
- 12. Two self-addressed envelopes (size 20 x 8cm) have to be annexed with the application form.
- 13. Applicants should keep on visiting regularly the University websites for dates of interview.
- 14. Reservation will be applicable as per Uttar Pradesh Government norms.
- 15. Applicants who are in employment should route their applications through proper channel or should submit a "No Objection Certificate" from the employer at the time of interview, failing which their candidature will be cancelled.
- 16. The University reserves the right of filling or not filling the advertised posts without assigning any reason.
- 17. Canvassing in any form may lead to cancellation of candidature.
- 18. The University reserves the right to increase/decrease the number of posts, at the time of selection.
